**Notice regarding Online Counselling for Post Graduate Medical (MD/MS/Diploma & DNB)
State Quota seats on the basis of NEET-PG -2025 Result**

Online Application Forms are invited from qualified eligible candidates of NEET PG – 2025 examination for the preparation of state merit list for conducting the online counselling for admission in Post-Graduate level Medical courses of State Quota seats. They must fulfill the following eligibility criteria :-

- a) The Candidates who have passed MBBS from any medical institute/college of Jharkhand state or those who are residents of Jharkhand state and had been admitted in MBBS course in Medical colleges of Bihar in session starting from the formation of the Jharkhand state or before the creation of the Jharkhand state and have passed MBBS from such colleges are eligible for admission in PG course in Medical College/Institute of the State as per Health Department Govt. of Jharkhand, Sankalp No.9/Namankan-02-02/2022-582 (9) dated 21.11.2022, It will be mandatory for them to produce Local Resident certificate issued by C.O./ S.D.O. (Civil) / D.C of the Jharkhand State.
 - b) Local Resident of Jharkhand state and serving Doctors in the State Government, even if they have passed MBBS examination from Medical College/Institute situated outside the state are eligible for admission on State Quota of PG seats. It will be mandatory for them to produce Local Resident certificate issued by C.O./ S.D.O. (Civil) / D.C. of the Jharkhand State.
 - c) Candidate must have Permanent /Temporary Registration from NMC or Jharkhand State Medical Council. Even in case of Temporary Registration, they will be eligible for admission in PG course, but it will be mandatory for them to get Permanent Registration by the last date of admission otherwise the admission of the candidate will be cancelled.
 - d) The candidate must have completed/ be going to complete the Rotating Internship for PG Medical by 31.07.2025.
2. **Reservation:-** Up-to-date Reservation Policies/Rules of the Govt. of Jharkhand will be applicable. Certificate issued by anyone other than Circle Officer/Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State shall not be entertained and will lead to rejection of his/her claim. No other document in support of his/her claims for caste will be entertained. Caste certificate produced by BC – I & BC – II candidates claiming reservation in their category will be accepted only if he/she does not belong to creamy layer & it should be mentioned clearly in their caste certificates. Certificates format are available under "Download" column of the Board's website.
3. Online counselling will be held as per letter no. – 7(A) Namankan-14.01.09/226 (7A) (dated 10.06.2011, sankalp no. 230(9) dated 22.12.15 and its amendment and sankalp no. 143(9) dated 06.04.2017 issued by Department of Health, Medical Education and Family Welfare, Govt. of Jharkhand.
4. Incentive marks will be provided for working in Rural & Remote Areas of Jharkhand as per Notification No. Sankalp No. 143(9) dated 06.04.2017. Format of Certificate for Medical Officer being posted in Remote and Difficult Areas notified by Govt. of Jharkhand has been hosted under "Download" column of Board's website <http://jceceb.jharkhand.gov.in>.
