With reference to the above cited subject, it is to inform that as per **Regulation 3 of National Commission for Homoeopathy (National Examinations in Homoeopathy) Regulations, 2023**, the colleges shall submit complete data of admitted students under various courses of homoeopathy as prescribed, failing which colleges shall also be imposed penalty of Rs.1,00,000/- per day.

In continuation, the colleges are directed to submit the data of students admitted through Central/State Counselling Authority / Government in Homoeopathy Undergraduate (BHMS) by 6:00 PM on 20.12.2025 & for Post Graduate (MD (Homoeopathy)) Courses by 6:00 PM on 22.12.2025, for Academic Year 2025-26, on AYUSH Education Portal.

That in situation where college is finding difficulty / unable to submit data through AYUSH Education Portal in prescribed time limit then the colleges shall submit the complete data of admitted student as per format in AYUSH Education Portal through excel and pdf file to the Commission, **essentially at Email Id: exam-nch@gov.in by 6:00 PM as per prescribed cut-off date for admission in Homoeopathy Undergraduate or Post-Graduate courses.**
